Contrary to her reputation as a recluse, Dickinson makes the startling decision to ask a famous editor for advice, writes anguished letters to

an unidentified "Master," and keeps up a lifelong friendship with writer Helen Hunt Jackson. At the peak of her literary productivity, she is seized with despair in confronting possible blindness.

It helps further understanding of factors that may influence teacher self-efficacy and suggests new directions for research to explore in future studies.

Söderblom Saarela focuses on people outside the Qing domain who had little interaction with Manchu speakers but who took an interest in the strange, new language of a rising world power. By exploring their first encounters with Manchu, he argues that their shared preoccupation with the script - the medium rather than the message - was intimately related to the globalization of the early modern period.

Naoi situates Yumeji's graphic art within the emerging media landscape from 1900s through the 1910s, when novel forms of reprographic communication helped create new spaces of visual culture and image circulation.

Her book draws on extensive research in both published and archival documents, including memoirs, newspaper and journal articles, political pamphlets, and Comintern archives. *Revolution Goes East* presents us with a compelling argument that the interwar Japanese Left replicated the Orientalist outlook of Marxism-Leninism in its relationship with the rest of Asia, and that this proved to be its undoing. Furthermore, Linkhoeva shows that Japanese imperial anticommunism was based on geopolitical interests for the stability of the empire rather than on fear of communist ideology.

In doing so, she highlights how schooling was conceived as a process of subjectification, creating particular modes of thought, behaviors, aspirations, and desires that would render the natives docile subjects amenable to American-style colonialism in the Philippines and occupation in Japan.
