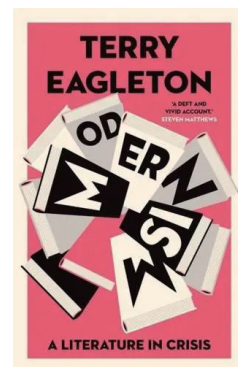

It was centred around feelings of growing alienation in an industrial world, and a desire to change how people live together in society. Art, architecture, literature, and music all underwent a radical revolution. Terry Eagleton presents a compelling and entertaining guide to modernism. From Ezra Pound to Virginia Woolf, James Joyce to H.D., Eagleton explores the literature and ideas of prominent modernists, emphasising the profound impact they had on subsequent generations.

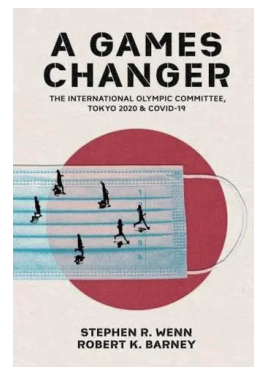
## A Games Changer: The International Olympic Committee, Tokyo 2020, and COVID-19

From the emergence of the COVID pandemic in early 2020 through the delayed staging of the Tokyo Olympic games in summer 2021, *A Games Changer* takes the reader behind the scenes to explore the myriad challenges the International Olympic Committee (IOC) and Japanese officials faced during the months of uncertainty leading up not only to the postponement of the Games but also to their delayed. Drawing on a thorough review of contemporary newspaper and magazine coverage as well as personal interviews with current and former IOC officials, Stephen R. Wenn and Robert K. Barney examine Japan's rising excitement in 2019 as preparations for the Games accelerated; whispers of a mysterious disease spreading first in China, then worldwide; organizers' initial resolve to press forward with the Games; the tumultuous discussions that ultimately resulted in the joint March 2020 decision by Japanese Prime Minister Shinzo Abe and IOC President Thomas Bach to postpone the Games; and the numerous negotiations with venues, media, and sponsors required to extend contracts and protect all parties' health. Wenn and Barney reveal how human relationships - among planners, politicians, competitors, and vaccine researchers - were vital to presenting an Olympics where, in July and August 2021, world records were set, deferred dreams were achieved, and fears of a superspreader event went unrealized.

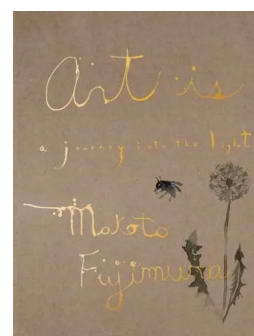

In this book, Fujimura takes readers along on his meandering journey as an artist. We witness him making his "process-driven slow art" - using pulverized minerals, gold, or pigments made from oyster shell - as he considers the plants and wildlife on the land where he lives. He draws on Japanese aesthetics, modernist art, Christian theology, sado (art of tea), literature, ecology, and personal narrative, with inspiration ranging from William Blake's poetry to the art of Mark Rothko and Josef Albers, and from the wisdom of Scripture and Japanese tea master Sen no Rikyū to the traditional Japanese painting technique called Nihonga. Bringing together the author's written reflections and his paintings, drawings, and photographs, *Art Is* invites us to see the world in prismatic and diverse lights, helping us navigate the fractured, divisive times we live in.

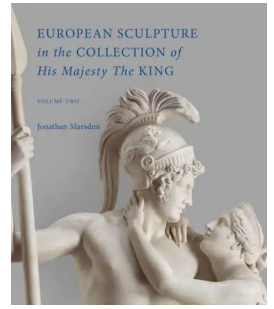

This four-volume publication marks the completion of one of the most ambitious stages in the long-term task of cataloguing sculpture in the Royal Collection. The scope of the catalogue - covering sculpture in all materials from the fifteenth to the late twentieth century - is unprecedented. Incorporating countless new attributions and identifications and the results of conservation and scientific examination, the catalogue will be an indispensable work of reference for all students of post-medieval sculpture, impressive not only in the quality of its scholarship but also for the extent and depth of the documentation. Highlights include an exceptional group of bronze busts from the Italian and Northern Renaissance, the first bronze casts of ancient sculpture to be made in Britain, the best ensemble of French seventeenth- and eighteenth-century bronzes outside France, unrivalled examples of English portrait sculpture from the seventeenth century onwards and the most complete surviving collection of Victorian sculpture.

This two-volume publication examines in depth the work of Samuel Yellin (1884-1940), a Ukrainian Jewish immigrant who became the single most important ironworker in America. It narrates his family's arrival and settling in Philadelphia and his immediate impact on the Pennsylvania Museum and School of Industrial Art. The rapid rise and sustained success of his business was founded on his relationships with renowned architects such as Paul Cret; Bertram Goodhue; Mellor, Meigs & Howe; George Washington Smith; and Ralph Walker. His devoted clients ranged from plutocrats Henry Clay Frick and J. P. Morgan Jr. to tastemakers Edward Bok and Edgar J. Kaufmann.

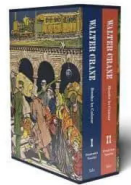

Born in 1845, Walter Crane was the first professional illustrator to proudly apply himself to commercial arts in the rising age of mechanical reproduction, he reformed the way his contemporaries perceived books, transforming them into influential, political, powerful objects to be pondered with intent and produced with art. Cheap as they were, they could still shape society, instil ideas and conjure worlds of possibility. His picture books served as a tool of popular education, helping to emancipate less well-to-do children and form their taste and personalities. They were of such artistic quality that they entered the homes of intellectuals such as Oscar Wilde and Dame Ellen Terry. This publication catalogues almost 450 titles illustrated by the artist, 274 of which have been newly discovered by Francesca Tancini, including unpublished illustrator's diaries and account books and printer's and publisher's ledgers and archives.

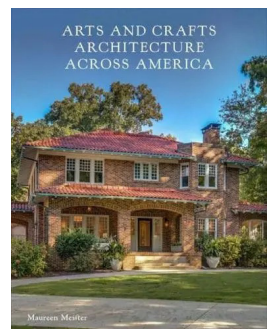

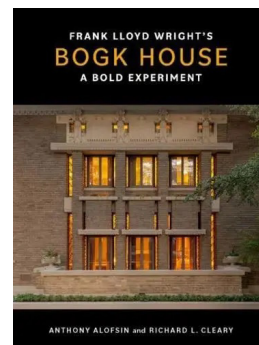

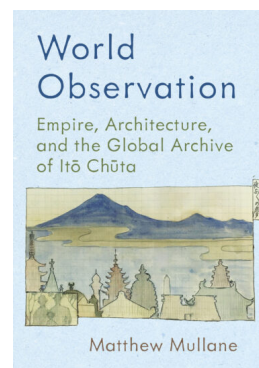

*World Observation* explores the archives and architecture of Itō Chūta (1867-1954), the eminent architectural thinker of the Japanese empire, who traveled across Asia, Europe, and North America to create the first world history of architecture in Japanese from a truly global set of encounters. In his mission to integrate Japan into existing world histories, legitimate Japanese colonial expansion, and train observers to see the world in the way that he did, Itō theorized new kinds of "observation" (kansatsu) in writing and drawing that strategically blended epistemological values from European science, philosophy, and anthropology with Japanese Buddhism, folklore, and naturalism.

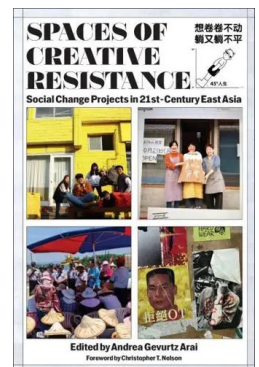

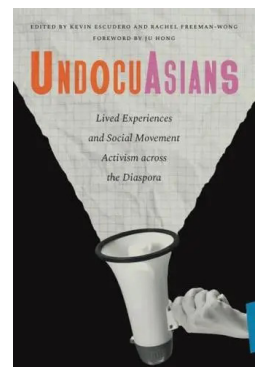

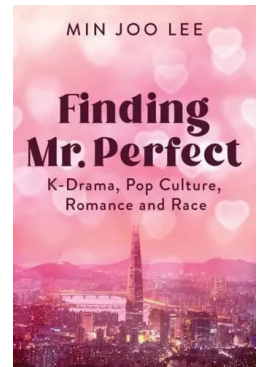

Author Min Joo Lee argues that disparate racialized erotic desires of Korean pop culture fans, foreign tourists to Korea, Korean men, and the Korean nation converge to configure the interracial and transnational relationships between these tourists and Korean men. Lee observes how racial prejudices are developed and manifested through interracial and transnational intimate desires and encounters. This book is the first to examine the interracial relationships between Hallyu tourists and Korean men. Furthermore, it is the first to analyze Korea as a popular romance tourist destination for heterosexual women.

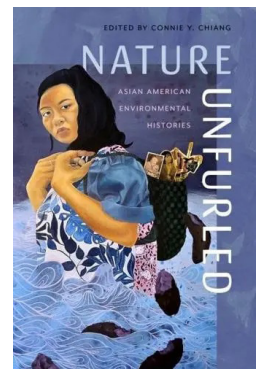

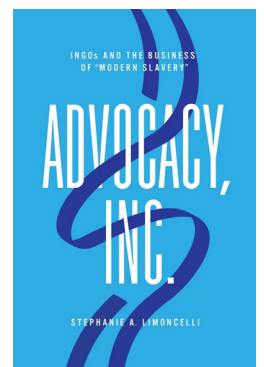

"Anti-slavery" advocacy has become a new market in which INGOs are pressed to become increasingly like for-profit businesses and the strategies they pursue do not adequately address the driving forces that have created conditions for continued labor exploitation in the global economy. Moreover, some businesses benefit from this scenario, having to do very little to claim 'hero' status in advocacy efforts, while practices that perpetuate labor exploitation continue unabated.

Peasant farming was once an integral part of Palestine's agrarian fabric. But after military occupation of the West Bank in 1967, Israeli land confiscations and economic policies pushed rural cultivators into wage labor. In recent decades, Palestinian land titling and private developers have driven the slow transformation of agricultural land into real estate. In *Plots and Deeds*, Paul Kohlby argues that we should see these changes as part of a larger process of agrarian annihilation, one in which state violence and market coercion together devastate the social, ecological, and economic relationships that make agrarian livelihoods possible.

The Japanese students in New Brunswick were young and innovative men of samurai and aristocratic lineage, who were sent by reform-minded leaders of Japan, which was undergoing a dramatic transformation. They came to New Brunswick seeking Western knowledge that was much needed for the modernization of a newly forming nation. New Brunswick became the hub of a network of Japanese nationals that extended to the major cities of New York, Philadelphia, and Boston, and from there to the smaller towns of New England. Once in New Brunswick, these Japanese students were embraced by Protestant ministers, educators, and missionaries - both men and women - whose network encompassed Rutgers College and the neighboring New Brunswick Theological Seminary, and which stretched to Dutch Reformed parishes throughout the Eastern seaboard, and westward as far as the Dutch enclave of Holland, Michigan. Meanwhile, the American teachers and missionaries who left for Japan became part of a network of reformist leaders and Japanese returnees that extended to schools, colleges, and missions in Japan, and formed the foundations of Japan's modern educational system. Through contributions from scholars and archivists in the U.S., Canada, and Japan, *Rutgers Meets Japan* aims to reconstruct the early Rutgers-Japan connections and examine the role and impact of this transnational network on Japan and the U.S. in the late nineteenth century.
