Following the Fukushima Daiichi Nuclear Power Plant disaster in 2011 many concerned citizens—particularly mothers—were unconvinced by the Japanese government's assurances that the country's food supply was safe. They took matters into their own hands, collecting their own scientific data that revealed radiation-contaminated food. In *Radiation Brain Moms and Citizen Scientists* Aya Hirata Kimura shows how, instead of being praised for their concern about their communities' health and safety, they faced stiff social sanctions, which dismissed their results by attributing them to the work of irrational and rumor-spreading women who lacked scientific knowledge.

By any measure, the battles of Bataan and Corregidor were among the most intensely fought and devastating episodes in the World War II Pacific theater. John A. Adams Jr. provides a new and compelling exploration of these pivotal events by recounting the history of Bataan and Corregidor through the eyes of 89 soldiers and officers who were former students and citizen soldiers from the Agricultural and Mechanical College of Texas. While many words have been written on Bataan and Corregidor, none have taken the approach of collective biography as The Fightin' Texas Aggie Defenders of Bataan and Corregidor does here.



Homecomings tells the story of these late-returning Japanese soldiers and their struggle to adapt to a newly peaceful and prosperous society. Yoshikuni Igarashi explores what Japanese society accepted and rejected, complicating the definition of a postwar consensus and prolonging the experience of war for both Japanese soldiers and the nation. He throws the postwar narrative of Japan's recovery into question, exposing the deeper, subtler damage done to a country that only belatedly faced the implications of its loss.



She examines the connections between the transnational dialogue on global indigeneity and multiculturalism, material culture, and the social construction of gender and ethnicity in Japanese society, and she proposes new directions for the study of settler colonialism and indigenous mobilization in other Asian and Pacific nations.
